C O R R I G E N D U M

In Reference to Haryana Staff Selection Commission's Advt. No. 3/2023, dated 07.03.2023, which was published in various newspapers and is available on HSSC Website i.e. www.hssc.gov.in., In Appendix-B and Appendix-C, the following corrigendum is issued for information of all CET qualified candidates,-

- a) In the essential qualification for the post of **Pharmacy Officer/Pharmacist** advertised against the **Category No. 139**, the following note shall be read at the end,-
"Note: - The candidates who have passed Diploma in Pharmacy or taken admission before the issuance of this notification will remain eligible for the post of Pharmacy Officer."
- b) In the essential qualification for the post of **Shift Attendant** advertised against the **Category No. 178**, under the essential qualifications be read as,-
 a) Matric with 02 years ITI course in Electrician/Electronics/Wireman trade or Lineman and Electrician (Maintenance & Repair of Electrical and Domestic Appliances) from VEI (Vocational Educational Institute with a minimum 60% marks in respect of General/other category candidates and 55% marks of SC category candidates of Haryana domicile.
- c) For the post of **Electrician** advertised against **category no. 183**, under the essential qualifications, '(ii)' may be read as,-
ii) ITI certificate in electrical trade along with 2 year experience of basic knowledge of Light Transmission and Heavy Transmission and (iii) 6 months certificate of Computer applications;
- d) In the essential qualifications for the post of **Proof Reader** advertised against the **category No. 322**, the same may be read as under;
"(i) Graduate of a recognised university having hindi or english as an elective subject or a graduate of a university having hindi or english as an elective subject at least in intermediated exam. Should possess knowledge of preparation of manuscripts of books for printing.
(ii) 5 Years experience of proof reading in Hindi and English in some printing press or organization of repute";
- e) Due to administrative reasons, **the posts advertised under Category No. 63, 64, 106 & 126 may be read as "Cancelled";**
- f) In the essential qualifications, for the post of '**Dietician**' advertised against **category No. 131**, the word, **M.Sc. "Dietician"** be read as **"M.Sc. Dietitics."**;

- h) In APPENDIX-C, Commission has modified the syllabus for the Group 56 (Common Graduate Level Examination) & Group 57 (Common Higher Secondary Level Examination) and the new syllabus is as below:-

Common Graduate Level (Level of Exam Graduate any discipline)

1) Haryana related history, current affairs, literature, Geography, Civics, Environment, Culture, art, traditions, and welfare schemes of Haryana Government etc.-

A. General Intelligence & Reasoning:

It would include questions of both verbal and non-verbal type. This component may include questions on analogies, similarities and differences, space visualization, spatial orientation, problem solving, analysis, judgment, decision making, visual memory, discrimination, observation, relationship concepts, arithmetical reasoning and figural classification, arithmetic number series, non-verbal series, coding and decoding, statement conclusion, syllogistic reasoning etc. The topics are, Semantic Analogy, Symbolic/Number Analogy, Figural Analogy, Semantic Classification, Symbolic/Number Classification, Figural Classification, Semantic Series, Number Series, Figural Series, Problem Solving, Word Building, Coding & de-coding, Numerical Operations, symbolic Operations, Trends, Space Orientation, Space Visualization, Venn Diagrams, Drawing inferences, Punched hole/ pattern- folding & un-folding, Figural Pattern-folding and completion, Indexing, Address matching, Date & city matching, Classification of centre codes/roll numbers, Small & Capital letters/numbers coding, decoding and classification, Embedded Figures, Critical thinking, Emotional Intelligence, Social Intelligence.

B. General Awareness:

Questions in this component will be aimed at testing the candidates' general awareness of the environment around him and its application to society. Questions will also be designed to test knowledge of current events and of such matters of every day observations and experience in their scientific aspect as may be expected of any educated person. The test will also include questions relating to India and its neighbouring countries especially pertaining History, Culture, Geography, Economic Scene, General Policy & Scientific Research.

Introduction to Indian Constitution: Preamble, Fundamental duties and fundamental rights only, Traffic Rules, Traffic signs, Penalties for violating traffic rules, first aid, safety precautions and occupational health, Welfare Schemes run by Government of Haryana and provisions.

C. Quantitative Aptitude:

The questions will be designed to test the ability of appropriate use of numbers and number sense of the candidate. The scope of the test will be computation of whole numbers, decimals, fractions and relationships between numbers, Percentage, Ratio & Proportion, Square roots, Averages, Interest, Profit and Loss, Discount, Partnership Business, Mixture and Allegation, Time and distance, Time & Work, Basic algebraic identities of School Algebra & Elementary surds, Graphs of Linear Equations, Triangle and its various kinds of centres, Congruence and similarity of triangles, Circle and its chords, tangents, angles subtended by chords of a circle, common tangents to two or more circles, Triangle, Quadrilaterals, Regular Polygons, Circle, Right Prism, Right Circular Cone, Right Circular Cylinder, Sphere, Hemispheres,

Rectangular Parallelepiped, Regular Right Pyramid with triangular or square base, Trigonometric ratio, Degree and Radian Measures, Standard Identities, Complementary angles, Heights and Distances, Histogram, Frequency polygon, Bar diagram & Pie chart.

D. Hindi & English Language:

Candidates' ability to understand correct Hindi/English, his/her basic comprehension and writing ability, Hindi & English terms used in offices and inter-translation etc. would be tested.
